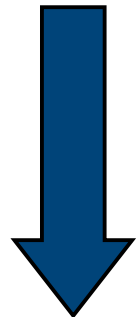
### SEASON COURT DETAILS

## BUYERS RIGHT TO CANCEL

If you wish to cancel this contract, you may cancel by mailing a written notice by certified or registered mail to the club. The notice must say that you do not wish to be bound by this contract and must be delivered or mailed before July 31<sup>st</sup>, 2011. After such time, you will be responsible for payment in full of the season court. After you cancel, the club may request the return of any/all contracts. The notice must be mailed (certified) to:

You may replace a player if they relocate their residence further than twenty-five miles from the club operated by the seller or from any other substantially similar club which would accept the obligation of the seller. This contract may also be cancelled if you die, or if the club ceases operation at the location where you entered into this contract. If you become disabled, you shall have the option of getting a substitute player to assume payment of that portion of the contract term for which you are disabled. You must prove such disability by a doctor's certificate, which certificate shall be enclosed with the written notice of disability sent to the club. The club may require that you be examined by another physician agreeable to you and the club at its expense. If you cancel, the club may keep or collect an amount equal to the fair market value of the services or use of facilities you have already received. The Club reserves the right not to renew any/all season courts.

### INTENSITY CLUB RULES

- 1) Court captains will be responsible for all payments on or before the first day of play.
- 2) Court captains will also be required to supply the club with all information concerning players in their group before the first day of play.
- 3) All players must sign in at the front desk.
- 4) A service charge of 1 1/2% will be assessed on past due accounts.
- 5) Make-ups will be given at the end of the season only if the club cannot fulfill seasonal court time responsibility.
- 6) Courts numbers may be reassigned at any time at the discretion of management.
- 7) Proper tennis attire required, no black soled shoes.
- 8) Use of all facilities are strictly at player's risk.
- 9) Any reserved open court or lesson must be cancelled at least 24 hours in advance else paid for in full.
- 10) Upon completion of assigned time, players are required to leave the court.
- 11) The Club reserves the right to cancel any membership for any cause deemed appropriate at the sole discretion of management including, but not limited to, the failure of any member to comply with the rules and regulations of the club.
- 12) Club reserves the right to provide instruction on adjacent courts; such instruction will only be given by authorized Club staff.
